PS: Havo issues this statement in respect of Module A of Self certification of the EU framework on the marketing of products (2008/768). This CE declaration of conformity is also valid for conformity in the UK as decided by the UK government (Jan24). FSC and PCR claims are backed by external certificates, available upon request. Vegan and our own claim "98% natural ingredients" are not backed by external certificates as an external vegan certificate is preferably for food and requires an unrealistic investment.
